2023 Expense Summary






Chapter Communications



Olivia Vidotta, Planner III Calvert County Southern Maryland

A new bridge is proposed to replace the current Thomas Johnson Bridge in Solomons between Calvert and St. Mary's counties. A St. Mary's County Commissioner launched a survey asking for community input on a potential toll bridge built by a private company. 93% of 2,257 people who voted were in opposition. The responses were from St. Mary's County, Calvert County, other counties within Maryland and 16 responses outside of Maryland. Discussion of a new bridge is still ongoing with future updates expected.

Calvert County Government is working on updating the Zoning Ordinance along with Master Plan updates. The draft is available online and there are public outreach sessions being held for review and comment.

A spring 2024 one-day conference is being planned to review agricultural uses with zoning restrictions and the solutions; A fall 2024 one-day conference is being planned to look at the challenges for commercial development and review other jurisdictions updated or proposed regulations and policies for commercial development.

Stephen worked on promoting the chapter throughout the network of Eastern Shore planners in opportunities that are common to their shared interests. This includes the Critical Area 40 year summit, Maryland Association of Counties summer conference, Maryland Planning Commissioners Association conference, Planners affiliate, NPC in addition to chapter activities and events; A fall 2024 one-day conference is being planned to look at the challenges for commercial development and review other jurisdictions updated or proposed regulations and policies for commercial development.

The pandemic was largely responsible for creating the Mid-Atlantic Planning Collaborative (MAPC) when we reached out to support West Virginia and involve other surrounding state chapters. It has been a huge boon to planning in the region with many training courses produced. It is particularly important in an area like western Maryland where professional planners are few and far between, which has made the role of representing them particularly challenging.

One of MAPC's webinars was very relevant in dealing with a different approach to implementable comprehensive planning. Two veteran Pennsylvania planners wrote this book: Off the Shelf and Into Action. It has demonstrated its effectiveness in several communities in the state and will probably be useful in Maryland.

The reliance on citizen planners is key to their owning and shaping their own communities. Remote areas like West Virginia have been an outstanding example of the necessity of educating and engaging citizen planners. This is why establishing more community planning academies is becoming essential in both rural and urban places.

The Maryland Planning Commissioner's fall conference was a terrific way to meet and work with a broad and diverse number of citizens already deeply involved with their communities and important connections were made. Also, MD-APA participated in the two-day Mobilize Frederick Climate Conference and was well received by a diverse group of people who weren't quite aware of all we do. There are more events like this that offer an opportunity to talk to 'regular people about how planning affects their lives and how they can participate.
